### NOVEMBER 20<sup>TH</sup> 1PT JUDGING SCHOOL by Pete Bergmann</sup>

Avoiding the common pitfalls of the Performance Verification Test


The PV is the hardest test that NCRS has. A Performance Verification is a required prerequisite step for a National Mark of Excellence award (Duntov, McLellan or Hill award). Most of us have heard about members or may have actually failed a PV themselves. There is nothing more disappointing than to witness a friend or owner travel long distances, spending a substantial amount of time and money. Only to fail for a simple reason. Upon witnessing this situation over and over, I decided to see what can be done to improve the odds of a successful outcome.

A poll was taken of the National Team leaders, National Judging chairman and actual owners who have gone through this evaluation. This presentation will show the results of this poll. In this judging school you will learn first hand what the experts suggest an owner should do to get the best possible chance of passing this test of your Corvettes functions.

This interactive Judging school was presented at the National Convention last summer in Palm Springs.

Please bring your questions and experiences so that everyone can benefit from the discussions.

NOTE: There is an overriding requirement that your National NCRS membership remain current and in good standing in order to maintain your Chapter membership. There are a few members who have expired or expiring national memberships this year.

Of the approximately 130 members that are part of the Arizona Chapter, 93 memberships will be expiring at the end of 2021. That means that 37 members are paid up through 2022, and some even out through 2025.

So how does one figure out if they actually need to renew their membership for 2022?


A great first place is to check your NCRS Profile. You can access this after you sign in to the NCRS website and then enter the Technical Forum. There you will see a tab labeled My Profile.

After you click on the tab, you will then need to click on the My Activity Visitor Messages About Me Friends About Me tab. A few lines down you will see the Chapter(s) you belong to, and in parentheses the year your membership expires. In the example at right, Chapter dues are paid out until **Basic Information** 2022. NCRS Chapters: If your membership expires in 2021, you guessed it, you have SERVICES STORE FOUNDATION Arizona Chapter (2022), to renew your membership this year for 2022. Renewing your membership via the NCRS website is simple, and like checking your status requires that you first be logged in to the system using your login ID and **Renew Membership** Password. **Technical Discussion Board** Go here to start the Chapter renewal process. Or, you can get there from the **Online Classified Ads** SERVICES drop down menu show at the right. **Coming Events** Once at the renewal page, you'll see information such as what Chapter(s) you belong Publications to and information regarding the renewal process. You next have to select the year to renew and for how many years. When you select the Year, you'll see a drop down list similar to what I show at left. If your membership expires in 2021, then 2022 will be the first year you can renew. If, like the example at left, you are already paid out through a future year, the first year eligible to renew will be listed first.

If you are paid out through 2022 or beyond, you do not have to do anything at this time. It's your choice if you want to continue and renew for future years.

### QUEST FOR DUNOV BY RAY GEIGER

194677S106207 Marina Blue Bright Blue, 327/350 hp, M20, AIR, one top Black vinyl hard top started when this Corvette was located for sale in Temecula, CA. in October 2017.

I was not aware of the high degree of originality until seeing the Corvette. Sellers had every registration since 1967, a photo album with the father at car shows and with Dave Burroughs of Bloomington Gold using this Corvette as an example of a "survivor", the original CA black & yellow license plates, and the original wheels with replacement tires.

We made a deal and after authenticating the title the '67 was on my trailer to AZ.

The next week in November 2017 was the AZ NCRS chapter judging meet. I drove '6207 40 miles to display our "new to us" Corvette. The general consensus of the judges was it was very original exterior, interior, chassis, with some clean up work done to the engine compartment.

At that point I decided to enter the AZ Regional May 2018.

It achieved a 97.8 % TOP FLIGHT. which prompted me to enter the 2018 NCRS Nationals in Las Vegas pursuing Star awards, of which the car achieved two Stars for Exterior and Interior.

Next was pursuit of the Performance Verification award at Frisco Texas Regional October 2018. With advice from friends, the car passed. Up next was a Bowtie/Star award DISPLAY at the Arizona Regional meet May 2021. We entered 194677S106207 at the NCRS National in Palm Springs, California trying for a 97% or better. And the Corvette did achieve the DUNTOV award with 98.2%

Loren S. Lundberg, 79, of Glendale, AZ, died Monday, July 5, 2021. Loren was

born in 1941 to Ida and Selmer Lundberg. He was raised in Grafton, North Da-

kota and graduated from Grafton High School in 1959. Loren served in the US

Army in Korea. Loren was a proud alumni of the University of North Dakota

undergraduate Accounting Department and School of Law. He was a lifelong

Tau Kappa Epsilon. After earning his Juris Doctorate from UND, Loren and family

relocated to Phoenix, AZ where he joined the AZ State Legislative Council. After serving as Director of the Legislative Council, Loren worked as an environmental

He is survived by his wife, Priscilla, sister Lyndis Webb (FL), sister-in-law Marilyn Lundberg (ND), and sister and brother-in-law Miriam and Terry Donnan (MN), son Jeffrey, daughter Kristen McEwen (Matthew) and grandchildren Amanda and Hadyn Lundberg and Kylie and Logan McEwen.

Introduced in 1929, just as the stock market crashed, the Model J was \$8,500 or \$120,000 today. In 1932 it went to \$9,500. (Guess Corvette read their

This is Jay's 1934 Model J. Built in Indianapolis, powered by 420-cubic-inch, 265-hp, twin-cam, 32-valve straight-eight, 36 of the 481 built were supercharged to 320 hp. This particular car is the only one ever windtunnel-developed. The company went out of business in 1937. You really need to see the car in person to appreciate the craftsmanship as it was totally restored by Randy Ema. This is the "Duesenberg Gallery" at Jay's.


#### A DAY AT JAY'S (CON'T)



You think you have a workshop that you're proud of, and you should be, but this fabricating shop indicates Jay's commitment to getting as much as possible done "in-house" as possible. He was interviewing craftsmen to bring upholstery work into the shop. By the way, see any dirt or old towels, etc. laying around?

Hey, where are the Corvettes? Honestly, we all know Corvettes and Jay doesn't have that big of a collection of them, in fact, we have members with larger collections than Jay. He is still awaiting a C8 since he gave his original order to a friend (I need friends like that, guess we all do.) Anyway, no pictures.

Yes, of course you need a static stand mounted Merlin aircraft engine, the engine built by Packard/Rolls Royce, known as "the engine that won the war." Why? Because these engines powered the P-51 Mustang fighter and the Lancaster bomber. Yes, the propeller on this unit has been but down to accommodate the mounting. Great video on his channel about the acquisition of the engine, the rebuild and starting it up at the garage. His garage complex, all 175,000 square feet, comprising six or seven buildings, is approximate to the Burbank airport. Convenient for a quick getaway.



Least you think he only has older collectable cars, motorcycles, aircraft motors, steam cars, and old electric cars, think again. These McLaren examples tell another story. Notice the F1, probably worth \$15 million and the Mercedes McLaren (silver car). And the beat goes on.



We managed to spend the entire day at the garage. Jay did some filming for Jay Leno's Garage in his studio, worked on beautiful Bentley and kid around with us. Wonderful human being, he is as he appears to be.
