HCC served 5,634 families; provided 168,463 pounds of food, hygiene, and baby items; 29,507 clothing items; and 5,862 volunteer hours were served. These numbers were just for the Phoenix facility. The Maryvale facility had similar numbers. So, if you ever wondered what happened to the money you donated, rest assured it was put to good use. Thanks again for donating to HCC.

The Concours in the Hills packed in over 1,050 cars (yes it was crowded) and raised more than \$250,000 for Phoenix Children's Hospital. The organizers had made a commitment to the hospital for \$500,000 over a five-year period but has accomplished that in 3 years all thanks to the automotive enthusiast community. Thanks to all the NCRS members who participated.

On January 25, the Arizona Chapter held a judging school in Fountain Hills regarding ELC Codes – What They Mean and How to Use During Judging. I have to give thanks to Bill Calorico for his tremendous help in conducting this school.

This event was held at the Fountain Hills Community Center which was a great location, very spacious and good parking for those that drove their Corvettes to the school. The Judging School went over the 1963 thru 1967 Corvettes on what ECL Codes identify on options for the St. Louis manufactured bodies since AO Smith manufactured bodies do not have ECL Codes. Since I am mainly a 68-72 C3 judge and don't judge C2 cars much, I learned a bunch from this presentation by Bill.





There were many questions asked during the event which was great for the knowledge that we all gained. A bunch of coffee was drank, donuts were eaten, and friends were seen so it was an overall successful Judging School.

### C1 CHASSIS & BODY JUDGING SCHOOL BY GARY CRAIG

On February 15, the Arizona Chapter held a combined judging school/technical session regarding C1 Chassis and Body Paint. The event was held at Garry Mion's garage where we had a chance to see the frame separated from the body.

Garry went over the various techniques used during the restoration of his 1960 Corvette on the chassis and underbody areas, showing paint overspray techniques, paint application techniques and many other smaller detailed items.











The body paint on the upper side of the body was very informative on the techniques used to make a good NCRS judged body paint and still maintain a great looking exterior finish.

The door jambs and hood/trunk drip rails had a very nice DOI (distinctness of image) that will judge quite well and the transition from these areas to the outer body paint was seamless, very good job Garry.



I have to thank Garry for conducting this judging school and technical session, it helps that members step up to show the rest of our membership what all their time and efforts have resulted in for our hobby.
